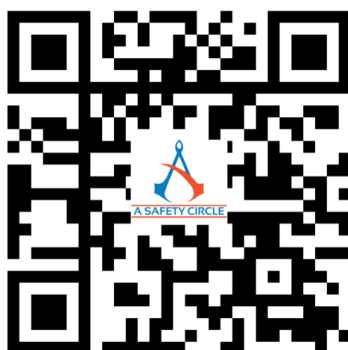

### Attention: California Fire Code Title 24, Chapter 4

#### Section 404.7.4

Emergency Director. Owner(s) and operator(s) of hotels, motels, lodging houses, high-rise office buildings, and Group I, Division 1 and 2 occupancies as defined in the California Building Code shall appoint a Fire Safety Director, who shall assure:

#### Section 404.7.5

Owner(s) or operator(s) of high-rise office buildings shall maintain a list of all permanent building tenants who have disabilities. Building owner(s) or operator(s) shall be notified in writing by those who have disabilities. Information provided in the list shall include any special emergency evacuation needs and permanent work location of such physically disabled persons. The list shall be located in the building manager's office.
